Carrying out the final state certification of graduates of the faculty of "Pharmacy evening training based on higher" biomedical education " and an interdisciplinary history exam of Kyrgyzstan, geography of Kyrgyz language and Literature

According with Regulation " of final state certification graduates of higher educational institutions KR", approved by the resolution Government KR of the Republic of Kazakhstan No. 346 dated May 29, 2012 and pursuant to the Order of the Ministry of Education and Science of the Republic of Kazakhstan No. 1455/1 dated November 27, 2017. #### 1. Approve it:

- conduct an expert review of the examination material no later than 20 days before the session, approve it at the relevant UMPC and submit it to the CRKNOZiPP
- provide students with training tests 4 weeks before the session set a date and time for consultations and bring it to the attention of students
- 4. Educational and Methodical Department:
- Provide the relevant dean's offices with the exam schedule
- provide a schedule of exams of the department two weeks before the certification
- carry out inspection control of the certification process
- provide students with access to the AVN system during the exam
- set the number of test tasks to 100 for each student
- set the response time for one test to 1.5 minutes

- To provide student turnout
- to monitor the progress of exams
